I. MOTION

The Board moves to proclaim its support and commitment to ensuring a full and accurate census count in 2010.

II. AGENDA ITEM SUMMARY

The Board heard from Gladys Romero of the U.S. Census Bureau on September 24, 2008. Ms. Romero discussed the importance of an accurate census, which will be taken in April of 2010. The Board was asked to proclaim that it supported and was committed to a full and accurate census. This proclamation indicates the Board's support.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. Board Action and Other History

The U.S. Census is only taken every 10 years. The Board 10 years ago formally indicated it's support of the U.S. Census and the County participated on a Complete Count Committee along with other partners in the community to ensure a full and accurate census count.

B. Policy Issues

Lane County is committed to its citizens. Ensuring that each and every one of Lane County's citizens is counted is the first step in ensuring fair representation and allocation of resources for those citizens.

C. Board Goals

Short term, the U.S. Census will provide much needed temporary jobs to citizens in our County. Longer term, the census will determine the distribution of \$300 billion annually of government funding for critical community services. The County is a full-service County, which is becoming more and more difficult to sustain. Ensuring that the County receives the funding it is entitled to will help the Board achieve it's short and long term goals for the County.

D. Financial and/or Resource Considerations

Much of the support the census will be requesting will not be monetary, but may require employee or elected official time to attend events, participate in a Complete Count Committee, etc. Such support is not required in order to proclaim support for the

Census, and each request may be evaluated at the time to determine if there are adequate resources.

E. Analysis

A complete and accurate Census will allow the County to received fair representation and allocation of resources. The actual taking of the Census will provide temporary jobs during a time when our local unemployment rate is 6%. Many decisions by the County are based, at least in part, on our understanding of the makeup and size of the communities that make up Lane County. Ensuring that every citizen in Lane County is counted in the official census is important to the future of the County.

- 2) The Board could vote to not support the proclamation
