### II. DISCUSSION

### A. Background/Analysis

The Lane County Animal Services Advisory Committee (LCASAC) was created as a part of BO# 07-10-31-10 and Lane Manual was updated to include the LCASAC via BO# 07-12-12-05.

The membership of the committee includes a designee appointed by each of the County Commissioners and two at large members, recommended to the Board by the committee.

There is currently an at-large vacancy due to the term expiration of the previous committee member. Eight applications were received in response to the vacancy. The committee recommends Marilyn Waters or Lisa Wolverton to fill the vacancy.

### B. Recommendation

Staff recommends that the Board appoint Marilyn Waters or Lisa Wolverton to the Lane County Animal Services Advisory Committee.

  County's very limited resources.
- 2. I am good at looking for common ground among diverse perspectives, and working toward compromises.
  - I think I could make a contribution in the areas of problem and solution analysis, generating ideas on items like spay & neuter promotion, adoption promotion, etc.
