I. MOTION:

Move adoption of Order.

II. ISSUE OR PROBLEM

On July 8, 2009, the Board of County Commissioners directed staff to prepare an order to allow Con Magnuson to make application to divide his property with payment of the fees for land divisions that were applicable in 1999. One way to accomplish that would be to reduce the current land division fees.

III. DISCUSSION

A. BACKGROUND

On October 22, 2008, Mr. Con Magnuson appeared at public comment stating that because the County did not implement the 1997 Airport Planning Rule until 2008, he should be able to make application to divide his property with payment of fees that were in effect in 1999. At that meeting Commissioner Dwyer suggested staff check into the land division fees in effect in 1999.

On July 8, 2009, the Board of County Commissioners directed staff to prepare an order that would allow Con Magnuson to make application to divide his property with payment of the fees for land divisions that were applicable in 1999.

B. ANALYSIS

In 1996, Lane County adopted its work program to implement the Periodic Review Order for the Lane County Rural Comprehensive Plan.

The State revised the Airport Planning Rule in 1997 (OAR 660-013-0160) and required local jurisdictions to amend their comprehensive plans to comply with the new requirements at their next scheduled Periodic Review. Since Lane County had already adopted its work program, the revised Airport Planning Rule requirements would not be applicable until Lane County's next Periodic Review cycle.

On June 24, 1998, the Board of Commissioners revised the Land Management application fees in Lane Manual 60.851 with the adoption of Order No. 98-6-24-32. The land division fees in effect in 1999 were as follows:

Preliminary Plat Subdivision fee - \$750 + \$100/lot, Plat Final fee - \$415 Preliminary partition fee - \$500, Final partition fee - \$330.

The current Lane Manual fees to process applications for land divisions represent full cost recovery and are as follows:

Preliminary Plat Subdivision fee - \$4,000 + \$200/lot, Plat Final fee - \$2,000. Preliminary partition fee - \$3,000, Final partition fee - \$1,500.

In 1999 Con Magnuson inquired about making application for partition of his airport property. Concerns were raised about the implications of proposed land divisions on the airport runway property. Mr. Magnuson never made application for land division of the property. Staff has still not been provided the specific land division being proposed at this time.

In 2007 Con Magnuson testified to the Board requesting the Land Management Division add implementation of the new Airport Planning Rule to its work program. In July 2007, the Board directed staff to make the necessary Rural Comprehensive Plan amendments to comply with the Airport Planning Rule the number one priority for the Long Range Planning Work Program.

In January 2008, the Board adopted Ordinance No. PA 1245 amending the Rural Comprehensive Plan to establish provisions for a Private Use Airport Overlay Zone applying the overlay zone to 5 private use airports, including the Con Magnuson private airport. It is not clear what the effect the Administrative Rule changes in 1997 and the action of the Board of Commissioners to apply the Private Use Airport Overlay Zone will have on the ability to divide the property.

Lane Manual 60.850 authorizes limited exceptions to the established fees. Since the Board of County Commissioners adopted the fees and limited the Public Works Director's authority to reduce fees, action by the Board to reduce the current fees

and apply 1999 fees to a potential applicant would seem to be the most effective way to address the Board direction. It is not clear how the Land Management Division will recoup the total costs for processing the land division applications authorized by the proposed order which will result in a loss of revenue to LMD in the amount of \$3650.

Attached please find a copy of the Board Order that allows for a reduced fee land division application to be submitted to LMD provided the application is submitted within the next two years.

C. CONCLUSION

The Board of County Commissioners directed staff to prepare an order reducing the current land division fees and allow Con Magnuson to make application to divide his property with payment of the fees for land divisions that were applicable in 1999.

RECOMMENDATION

No Staff recommendation. This is a Board decision as previously discussed.
