

DEDICATION OF A PUBLIC ROAD EASEMENT

GRANTOR, grants and dedicates to LANE COUNTY, a political subdivision of the State of Oregon (GRANTEE) a public road easement on and over the following described property:

A parcel of land lying in the Northeast 1/4 (NE ¼) of Section 6, Township 16 South, Range 4 West of the Willamette Meridian, and being a portion of the tract of land conveyed to Stephen Bean, by a certain Statutory Warranty Deed, recorded on Recorder's Reception Number 2008-063745, Lane County, Oregon, Deed Records, said parcel being more particularly described as follows:

Beginning at a point on the easterly right-of-way line of Pitney Lane (County Road 602), being South 0°03'35" East 334.95 feet and South 89°10'58" East 20.00 feet from the north one-quarter corner of Section 6 of Township 16 South, Range 4 West of the Willamette Meridian; run thence South 89°10'58" East 10.00 feet to a 5/8" iron rod with yellow plastic cap marked "R. Skinner PLS 869"; thence South 0°03'35" East 205.00 feet to a ½" iron rod set in CSF 28300; thence North 89°10'58" West 10.00 feet to said right-of-way line; thence northerly along said right-of-way line, North 0°03'35" West 205.00 feet to the Point of Beginning, all in the City of Junction City, Lane County, Oregon.

The bearings used herein are based upon a Partition Plat for Stephen Bean, to be filed as a survey in the Office of the Lane County Surveyor.

It being the intent herein to acquire right-of-way for Pitney (County Road Number 602) which, with this dedication, will result in a right-of-way width of 30.0 feet from centerline as said road abuts the GRANTOR'S property.

There is no consideration for this dedication.

Said parcel being forever dedicated to the use of the public for road purposes and granting a public road easement.
