**THIS MATTER** now coming before the Board of County Commissioners of Lane County and Stephen Bean, owning land within Lane County which is within the limits of the City of Junction City, having on this day presented to the Board of County Commissioners of Lane County a good and sufficient dedication, said dedication being properly executed and forever dedicating a portion of such land to the use of the public for road purposes and granting a public road easement, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept said dedication for a public road easement;

**NOW, THEREFORE, IT IS HEREBY ORDERED** that the said dedication shall be and is hereby accepted by the Board of County Commissioners of Lane County as a public road easement; and

**IT IS FURTHER ORDERED** that the described right-of-way is expressly accepted as a County Road by this Order; and

**IT IS FURTHER ORDERED** that the above Order shall be entered in the records of the Board of County Commissioners' Journal of Administration and in the road records for County Road Number 602 in the regular numbered road files in the County Surveyor's Office; and

**IT IS FURTHER ORDERED** that the dedication be recorded in the Deed Records of the County and the Document Number be noted on this Order.

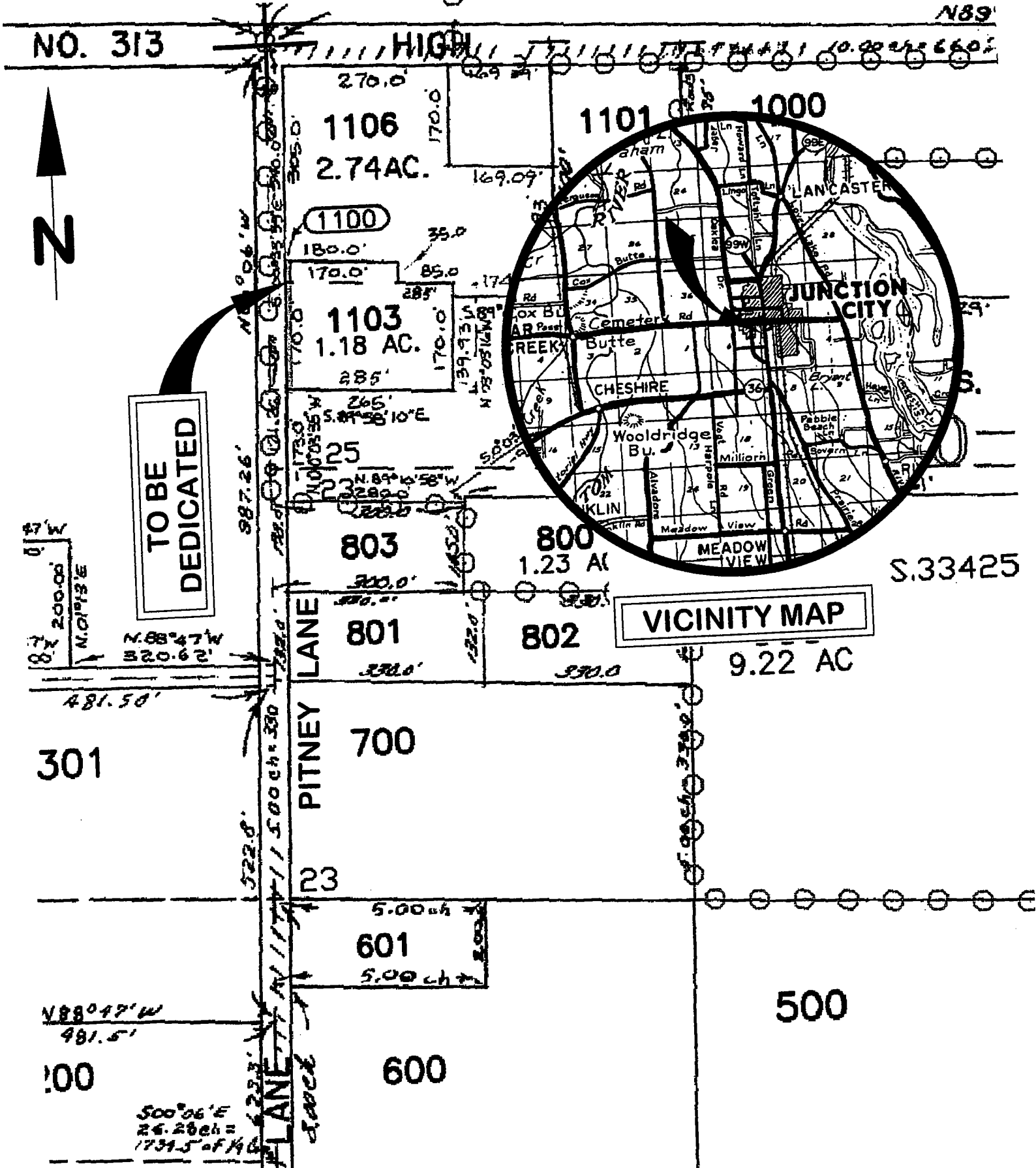

**DEDICATION OF A PUBLIC ROAD EASEMENT**

**Stephen Bean**

**GRANTOR**, grants and dedicates to LANE COUNTY, a political subdivision of the State of Oregon (**GRANTEE**) a public road easement on and over the following described property:

A parcel of land lying in the Northeast 1/4 (NE ¼) of Section 6, Township 16 South, Range 4 West of the Willamette Meridian, and being a portion of the tract of land conveyed to Stephen Bean, by a certain Statutory Warranty Deed, recorded on Recorder's Reception Number 2008-063745, Lane County, Oregon, Deed Records, said parcel being more particularly described as follows:

Beginning at a point on the easterly right-of-way line of Pitney Lane (County Road 602), being South 0°03'35" East 334.95 feet and South 89°10'58" East 20.00 feet from the north one-quarter corner of Section 6 of Township 16 South, Range 4 West of the Willamette Meridian; run thence South 89°10'58" East 10.00 feet to a 5/8" iron rod with yellow plastic cap marked "R. Skinner PLS 869"; thence South 0°03'35" East 205.00 feet to a 1/2" iron rod set in CSF 28300; thence North 89°10'58" West 10.00 feet to said right-of-way line; thence northerly along said right-of-way line, North 0°03'35" West 205.00 feet to the Point of Beginning, all in the City of Junction City, Lane County, Oregon.

The bearings used herein are based upon a Partition Plat for Stephen Bean, to be filed as a survey in the Office of the Lane County Surveyor.

It being the intent herein to acquire right-of-way for Pitney (County Road Number 602) which, with this dedication, will result in a right-of-way width of 30.0 feet from centerline as said road abuts the GRANTOR'S property.

There is no consideration for this dedication.

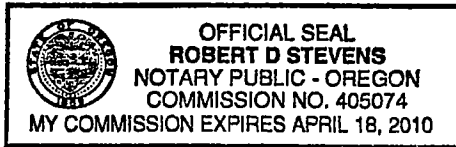
Said parcel being forever dedicated to the use of the public for road purposes and granting a public road easement.
