II. DISCUSSION

A. <u>Background / Analysis</u>

The Department of Health & Human Services has contracts and amendments that were not included in the budget adoption order for a number of reasons including competitive process not being completed, continuing contract negotiations and contract amounts not being finalized. Additionally, contracts and amendments submitted as part of Supplemental 4 were inadvertently left off of the contract list. The County Administrator agreed to execute the one contract and three amendments slated for Supplemental 4 in anticipation of this order being approved, therefore his signature must be ratified on those four agreements. Health & Human Services is also requesting ratification of his signature on an amendment with Hayden Dental which had to be signed by the County by July 9th. We received the amendment July 7th. This contract must remain in effect in order for the Community Health Center to be able to bill for wrap payments for dental services.
