DEDICATION OF A PUBLIC ROAD EASEMENT

Lorin J. Bailey and Jerrold W. Gates

GRANTORS, grant and dedicate to LANE COUNTY, a political subdivision of the State of Oregon (GRANTEE) a public road easement on and over the following described property:

A parcel of land lying in the Northeast One Quarter (NE ¼) of Section 5, Township 21 South, Range 3 West of the Willamette Meridian, and being a portion of the tract of land conveyed to Lorin J. Bailey, by that certain Bargain and Sale Deed recorded March 21, 2008 on Recorder's Reception Number 2008-016155, and also a portion of the tract of land conveyed to Jerrold W. Gates, by that certain Statutory Bargain and Sale Deed, recorded April 10, 2009 on Recorder's Reception Number 2009-018387, Lane County, Oregon, Deed Records, and said parcel being more particularly described as follows:

Beginning at a point 1808.30 feet East and 201.80 feet North of the Southwest corner of Donation Lane Claim No. 47 in Township 21 South, Range 3 West of the Willamette Meridian and running thence East 838.19 feet to a point; thence 5.42 feet along the arc of a 680.00 foot radius curve to the left, having a central angle of 0°27'23", by a long chord that bears South 33°08'46" East 5.42 feet to a point; thence North 89°58'58" West 841.15 feet to a point; thence North 4.28 feet to the point of beginning, being all in Section 5 of said Township and Range, Lane County, Oregon.

The bearings used herein are based upon a Partition Plat for Lorin J. Bailey and Jerrold W. Gates to be filed as a survey in the Office of the Lane County Surveyor.

It being the intent herein to acquire right-of-way for Emerson Lane, a public road, for the purpose of widening the road as it abuts the GRANTOR'S property.

There is no consideration for this dedication.
