# I. MOTION

## II. <u>DISCUSSION</u>

# A. Background / Analysis

The Board of Commissioners has approved contributions to the Eugene-Springfield NAACP Afro-Academic, Cultural, Technological, Scientific Olympics (ACTSO) program since 2003. Each year the amount of the contribution was \$5,000.

At the Board's June 17<sup>th</sup> meeting Commissioner Sorenson asked that a proclamation be prepared to show Lane County's support of the 2009 ACTSO program. The first attachment in this packet is a proclamation prepared by Zoe Gilstrap.

Further, a motion was made by Commissioner Dwyer to approve a contribution to the ACTSO program for 2009. In his initial statement, Commissioner Dwyer said he thought the previous amount had been \$1,500. Later he stated that he wanted the contribution to be whatever is was in the previous year. While this motion was seconded by Commissioner Stewart, a final vote was not taken, thus requiring Board action today.

Attached is a copy of Board Order 07-8-14-6 showing last year's \$5,000 contribution. Also attached are two identical orders except for the dollar amount for Board consideration. The first order is for \$5,000 to match the amount contributed over the last five to six years. The second order is for \$1,500, the amount Commissioner Dwyer initially mentioned.

## B. Recommendation

The Board needs to make two decisions: 1) modify and/or approve the attached proclamation, 2) choose which amount they want to contribute to the 2009 ACTSO program.

I recommend the Board approve the attached proclamation as written.

I further recommend the Board adopt the order contributing \$5,000 to ACTSO consistent with all prior year contributions.
