I. MOTION

Move that the Lane County Board of County Commissioners proclaim the week of May 17, 2009 through May 23, 2009 Lane County Public Works Week.

II. <u>DISCUSSION</u>

A. <u>Background/Analysis</u>

National Public Works Week is a celebration of the tens of thousands of men and women in North America who provide and maintain the infrastructure and services collectively known as public works. Instituted as a public education campaign in 1960, National Public Works Week calls attention to the importance of public works in community life. The Week seeks to enhance the prestige of the often—unsung heroes of our society—the professionals who serve the public good every day with quiet dedication.

Over the years, public works agencies and professionals have been encouraged to take the opportunity to make their stories known in their communities. The occasion has been marked each year with scores of resolutions and proclamations from mayors, county commissions, and governors. Some special highlights of NPWW include a United States Senate resolution affirming the first National Public Works Week in 1960, letters of acknowledgment from Presidents Dwight Eisenhower and Lyndon Johnson, and a Presidential Proclamation signed by John F. Kennedy in 1962.


