II. AGENDA ITEM SUMMARY

The terms of a proposed Right of Way Services Agreement to be executed with Oregon Department of Transportation (ODOT) in connection with the Lost Creek – Parvin Covered Bridge Rehabilitation Project require that the County adopt a resolution of intention and determination of necessity authorizing acquistion of the right of way needed for the project. The Resolution includes authority to commence and prosecute an action in the Circuit Court of Lane County to condemn and immediately occupy the real property needed for the project if County staff is not able by negotiations to reach an agreement for the acquistion of the property.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. Board Action and Other History

By Order 6-11-1-3 the Board ratified a grant application submitted by Public Works staff under the 2006 Historic Bridge Preservation Program for rehabilitation of the Lost Creek – Parvin Covered Bridge. The grant has been approved in the amount of \$733,722.00, supplemented with an additional Highway Bridge Program (HBP) grant in the amount of \$64,606.00. The project is scheduled to go out for bid in March 2010.

In order to complete the planned work and to allow continuing maintenance once the project is completed, small areas of additional right of way are required on both sides of Lost Creek as shown on the attached Preliminary Right of Way Map marked as "Attachment 1". The properties to be affected by the project are as shown on the List of Affected Properties attached and marked as "Exhibit A".

B. Policy Issues

Execution of the Right of Way Services Agreement and adoption of the Resolution of Necessity is in accordance with the terms of the IGA between the State of Oregon (ODOT) and Lane County executed pursuant to the approval of the two grants used to fund the project.

Adoption of the Resolution is required prior to initiation of any acquisition pursuant to ORS 35.610.

C. Board Goals

Repair of this bridge is consistent with the County Goals of contributing "to appropriate community development in the area of transportation and telecommunications infrastructure, housing, growth management and land development", and protection of the "public's assets by maintaining, replacing or upgrading the County's investments in systems and capital infrastructure". Also in the <u>Lane County Strategic Plan</u> under Section B-3(d)(6), it is stated that "Operation, maintenance and preservation (OM&P) of the existing County road system will receive the highest priority".

D. Financial and/or Resource Considerations

Lane County is obligated for project cost over and above the total amount of the two grants. The adopted <u>Lane County Public Works Capital Improvement Program 2010-2014</u> includes \$83,290 in Year 09/10 to allow for the County's match in excess of the grants.

E. Analysis

This bridge is in need of major repairs to preserve and restore its useful life. The grants are covering approximately 89.73% of project costs based on estimates prepared at the time of grant approval.

F. Alternatives/Options

- 1. Approve the Resolution authorizing acquisition of the needed right of way.
- 2. Deny the order and/or direct staff otherwise.


Upon approval of the Resolution, staff will proceed with the acquisition of the right of way.

WHEREAS, by Order 06-11-1-3 the Board ratified the grant application submitted by staff under the National Historic Bridge Preservation Program for the rehabilitation of Lost Creek – Parvin Covered Bridge; and

WHEREAS, said grant was subsequently approved in the amount of \$733,722 and a Highway Bridge Program Grant was also approved in the amount of \$64,606 for use in the rehabilitation project; and

WHEREAS, Lane County has entered into an Intergovernmental Agreement with the State of Oregon concerning said project and said Agreement requires that the County enter into a Right of Way Services Agreement which includes a requirement that the Board adopt a resolution and determination of necessity authorizing the acquisition of necessary right of way for said project; and

WHEREAS, such a resolution is required pursuant to ORS 35.610; and

WHEREAS, said project is scheduled to be advertised for bids in March, 2010 and to be constructed during the 2010 construction season; NOW, THEREFORE, IT IS HEREBY

RESOLVED that under authority granted in ORS Chapter 35 there exists a necessity to acquire and immediately occupy portions of real property as shown on attached "Exhibit A" in order to construct said bridge rehabilitation project to serve the needs of Lane County for the general use and benefit of Lane County, and that the proposed use, improvement or project is planned or located in a manner which will be most compatible with the greatest public good and the least private injury; **AND**, **BE IT**

RESOLVED AND ORDERED, that the Director of the Department of Public Works or the Director's representative is hereby delegated the authority to purchase the necessary real property in accordance with Lane Manual Chapter 21 and to execute related instruments to accomplish the property acquisition. If Lane County is unable by negotiations to reach an agreement for the acquisition of the necessary real property rights, the Office of Legal Counsel of Lane County is hereby authorized to commence and prosecute in the Circuit Court of Lane County, in the name of Lane County, any necessary proceedings for the condemnation and immediate possession of necessary real property rights and for the assessment of damages for the taking thereof.
