Finding solutions to noise problems

Effective July 1, 1991, the state Department of Environmental Quality (DEQ) Noise Control Program was terminated. DEQ eliminated the program as a cost-saving measure, in anticipation of reduced revenue.

Were the State noise regulations rescinded?

No. The state noise regulations remain on the books. Regulated sources of noise are legally responsible for complying with all applicable provisions and standards, even though DEQ no longer investigates noise complaints.

What types of State noise standards are there?

State regulations have standards for:

- New and used motor vehicles
- Industry and commerce
- Motor sports vehicles and facilities
- Airports

What other agencies investigate noise problems?

Several Oregon cities and counties have enacted local noise ordinances. Other state and federal agencies also regulate noise. For example, the State Marine Board regulates noise from boats, with enforcement of suspected boat-noise violations handled primarily through county marine enforcement offices; the Oregon Liquor Control Commission regulates noise from licensed liquor establishments.

What Other Enforcement Options are There?

- Enforcement of local government noise or public nuisance ordinances.
- Class B misdemeanor criminal action for violation of the state noise statutes or the state disorderly misconduct statutes.

What types of local noise standards are there?

Standards vary from city to city and county to county. Some jurisdictions use the state standards; others have enacted separate standards. A couple of cities have standards that are more stringent than the state's. In general, most local regulations include standards for:

- Heat pumps and air conditioner units
- Amplified music from musical groups and car stereos
- Off-road ATVs, motorcycles, and dune buggies
- Loud speakers

Who Enforces Local Standards?

Generally, the county sheriff and city police departments investigate noise complaints and initiate enforcement actions. In some cases, the local codes enforcement office assumes this responsibility.

RE: Excessive Noise from Goshen Forest Products
Revision to Lane Code

Dear Chair Sorensen and Members of the Lane County Board of Commissioners:

I live at 33933 Hampton Road, Eugene, Oregon 97405 which is directly across the street from Goshen Forest Products. Over the last year, the company has subjected my property to excessive noise by virtue of the operation of a de-barker and chipper. I have shown the company officials my sound readings showing violation of both the state code and county regulations and yet the excessive noise continues. The noise is unrelenting and it interferes with my sleep and utterly destroys my ability to quietly enjoy my home.

In trying to get the company to comply with existing noise regulations I have hit a legal road block. The state has suspended enforcement of its noise regulations since 1991. A copy of their website notice to this effect is attached. See also OAR 340-035-0110.

In conversations with your land use enforcement staff, I have learned that noise caused by industrial organizations may be excepted from enforcement. See Lane Code 5.620(6).

It does not seem right that both the State and the County can refuse to enforce their regulations on excessive noise and that I am left without a remedy. I, therefore, respectfully request that you amend the Lane Code exception in Lane Code 5.620(6) to state as follows:

"(6) Sounds caused by commercial, industrial, agricultural, timber harvesting, utility or construction organizations or workers during their normal operations. This exception does not apply during any period that the State of Oregon, Department of Environmental Quality has suspended enforcement of its noise control regulation." (New language is in bold.)

I respectfully request that you ask County Counsel to draft such an amendment and schedule a public hearing on such a proposal.
