# I. MOTION

Move approval of the order in the matter of awarding contracts to Family Relief Nursery in the amount of \$372,176, Relief Nursery, Inc., in the amount of \$598,167 and CASA in the amount of \$158,240 for the period of July 1, 2009 through June 30, 2011 and delegating authority to the County Administrator to execute the contracts.

### II. DISCUSSION

# A. Background / Analysis:

The State of Oregon previously released 90 days of funding to the Oregon Commission on Children and Families (OCCF) as a continuing resolution to bridge resources to OCCF and the 36 county commissions until the 2009-11 budget had been signed by the Governor and the State Commission had approved the allocations to the counties. The Lane County Board of Commissioners approved the initial continuing resolution agreement and delegated authority to the County Administrator to execute the agreement and approved the Lane County Commission on Children and Families initial budget allocation by Order No. 09-7-21-1 at their regular meeting on July 21, 2009.

The 2009-11 budget has been signed by the Governor and OCCF has approved the 36 county allocations, and an amendment has been received with the remainder of the biennial allocation. The Lane County Board of Commissioners approved the amended Lane County Commission on Children and Families budget allocation by Order No. 09-8-4-1 at their regular meeting on July 29, 2009 and delegated authority to the County Administrator to execute it.

Funding allocations for both Lane County Relief Nurseries and CASA are directed by the Oregon Commission on Children and Families in compliance with HB 5004, therefore no competitive process is required for any of these contracts.

#### B. Recommendation:

Staff recommends approving the order in the matter of awarding contracts to Family Relief Nursery in the amount of \$372,176, Relief Nursery, Inc., in the amount of \$598,167 and CASA in the amount of \$158,240 for the period of July 1, 2009 through June 30, 2011 and delegating authority to the County Administrator to execute the contracts.
