I. MOTION

MOVE TO AWARD A CONTRACT TO CLACKAMAS CONSTRUCTION FOR \$455,996 AND A CONTRACT TO THE AUTOMATION GROUP FOR \$50,335, AND AUTHORIZE THE COUNTY ADMINISTRATOR TO SIGN CONTRACT DOCUMENTS

II. AGENDA ITEM SUMMARY

Lane County was awarded a \$1,000,000 Community Development Block Grant (CDBG) in March 2009 to make improvements to the Row River Valley Water District water treatment facilities. The next and final task in the project that needs to be undertaken is completion of the water treatment plant.

After following the prescribed request for proposal process for competitive selection of a construction company and system programming, proposed contracts have been negotiated with

- a) Clackamas Construction for construction of the water treatment plant for an amount not to exceed \$455,996, and
- b) The Automation Group for telemetry and system controls, for an amount not to exceed \$50,335.

Clackamas Construction was the low bidder for the construction project elements. The Automation Group was the only bidder for telemetry elements, but their quote was below the engineers estimate for this work.

Approval of the attached Board Order will allow the County to enter into the contracts with Clackamas Construction and The Automation Group and the final stage of the project to begin.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. Board Action and Other History

The Row River Valley Water District serves the communities of Dorena and Culp Creek to the east of Dorena Lake. The District is operating an aging water treatment system to treat drinking water for about 300 residents in the area. On behalf of the District, Lane County submitted a grant request that was awarded \$1,000,000 from the Oregon Business Development Department, using federal Community Development Block Grant (CDBG) funds.

The Board of County Commissioners approved Board Order 09-3-18-11 accepting the grant. Since that time, the environmental documents required for the project have been completed as well as the installation of the water treatment tank. The next and final step in the process is to complete the water treatment plant.

A competitive request for proposal document and process for construction services was prepared by County staff working with the Row River Valley Water District.

On May 14th, 19th and 26th, the Register Guard, Daily Journal of Commerce and the Cottage Grove Sentinel published Lane County's legal ad requesting proposals from licensed Oregon contractors. The proposal due date was June 9, 2010.

Seven Bids came in for the water system improvements with prices ranging from \$455,996.00 for the low bid and the \$551,983.00 for the high bid. The Engineer's estimate for construction cost of the improvements was \$550,000.00.

The seven responsive bidders for the water system improvements are as follows:

Clackamas Construction, Inc. at \$455,996.00, Taylor Site Development, Inc. at \$513,000.00, Stettler Supply& Construction at \$527,400.00, Triad Mechanical, Inc. at \$541,956.00, Schneider Equipment, Inc. at \$542,400.00, TEK Construction, Inc. at \$551,518.00, 2G Construction at \$551,983.00,

In addition, one bid was received for systems programming and control items from The Automation Group, Inc. at \$50,335.00. The Engineer's estimate for the cost of these items was \$55,000.00.

Based on the bid results and proposed subcontractor lists received for the above referenced job, it was recommend by the County's consultant, Civil West Engineering, to award the bids as follows:

- a) Clackamas Construction for construction of the water treatment plant for an amount not to exceed \$455,996, and
- b) The Automation Group for telemetry and system controls, for an amount not to exceed \$50,335.

The RFP review team, consisting of the Lane County Community and Economic Development Coordinator, the Lane County Community and Economic Development Program Specialist, the Row River Valley Water District Board Chair, a Row River Valley Water District Board Member and the Row River Valley Water District Attorney, reviewed the responses and found that they conformed to all RFP requirements.

The review team also evaluated the proposal on a variety of factors including Price, Scope of Proposed Services; Familiarity with project locale; Professional Qualifications; Demonstration of CDBG project experience and Performance Examples.

A contract for Professional Services has been developed by Lane County for this project. The contract has been reviewed and approved by the Board of Directors for the Row River Valley Water District and by our State CDBG liaison.

The next step in the contract process is for the Board of Commissioners to approve the order awarding contracts to Clackamas Construction and The Automation Group. Upon approval of the Board Order the contracts will be submitted into the county contract approval process, which includes review by County legal staff.

B. Policy Issues

This project is an example of the Board of Commissioner's policy to assist the rural communities of Lane County in solving infrastructure issues.

In moving to the next phase of this project – construction of the water treatment plant – County staff has followed CDBG and County policy issues regarding the solicitation for services and the selection process of contractors.

The Board has the following policy issues to consider:

1) Should the County contract with Clackamas Construction and The Automation Group in order to undertake this construction of the water treatment plant?

C. Board Goals

The Row River Valley Water District water treatment plant project meets the following Board goals:

- 1) Develop Lane County's economic engine
- 2) Provide outstanding customer/constituent service
- 3) Build public trust through intensive communication and engagement

D. Financial and/or Resource Considerations

The entire \$445,996 construction contract and \$50,335 system programming and control contract is being paid from the CDBG funds awarded for this project and the Row River Valley Water District's matching funds. There are no general fund dollars being used for this project. The construction services contract fits into the project budget of \$550,000 and the system programming and control items contract fits into the project budget of \$55,000.

E. Analysis

The competitive request for service process met County and state CDBG program requirements. The result of the process is that we have a selected a qualified construction company and system programming company. The cost of their services fits within the budgeted amounts for the work that has been identified as necessary to successfully undertake and complete this project.

F. Alternatives/Options

The options before the Board are as follows:

- 1. Approve awarding a contract to Clackamas Construction and The Automation Group.
- The Board may take no action. This would result in at least a delay in the project until the matters of concern to the Board could be resolved.
- 3. The Board may choose to reject the proposed contracts and place

the project back out for request for proposals.

IV. TIMING/IMPLEMENTATION

We are moving forward with an aggressive timeline in the hopes the work done at the Row River water plant is completed by September 2010. In order to meet that timeline, we need to have a construction company and system programming company on board and working on the completion of the water treatment plant. Upon Board approval of the hiring of both of these companies, we expect them to begin work almost immediately.

V. RECOMMENDATION

Staff recommends that the Board adopt the proposed Order.

VI. FOLLOW-UP

Upon approval of the Board, C&ED staff will work with County Counsel to get the contract signed.

WHEREAS, the Board of County Commissioners previously adopted Resolution/Order No. 09-3-18-11 to sign the CDBG agreements with Oregon Business Development Department and all related grant documents pertaining to the Row River Water System Improvement Project; and

WHEREAS, Lane County solicited proposals for professional services for the construction services and system programming to be performed as a part of the grant award and received seven responsive construction proposals and one responsive system programming proposal; and

WHEREAS, Lane County working with the Row River Valley Water District, has reviewed the proposals for professional services; and

WHEREAS, after reviewing the proposals, Lane County has selected Clackamas Construction and The Automation Group as the respondents most capable of performing the desired services within the budget of the CDBG award;

NOW THEREFORE IT IS HEREBY RESOLVED AND ORDERED that the Lane County Board of Commissioners does hereby approve contracting with Clackamas Construction for an amount not to exceed \$455,996 and The Automation Group for an amount not to exceed \$50,335; and further delegates authority to the County Administrator to execute such a contracts.

Scope Narrative:

This proposal is for the integration and controls items that were discussed on 5/27/10 for the Row River project which bids on 6/9/10. Our proposal is based on Time and Materials billings with both a budgetary amount and a contingency amount. The contingency amount is to be available for any available line item where either through further investigation or mutual consideration either a change in scope or pre-design oversight has imposed costs beyond what was originally estimated.

PLC/HMI/SCADA system programming includes interfacing with the Siemens Water Technologies (USFilter) contractor to provide an operator workstation remote from the equipment for monitoring and control. Conversations have been had with Siemens technicians and it has been expressed that they will be cooperative in this effort.

The Studio Development software is not specifically required for the operation of the facility. By having it installed on the SCADA computer it would allow easy program modifications/development and would be a time-saving item that will reduce further development costs for the system. It has been included for your consideration on this project solely as a courtesy to our customer and is NOT required for operation.

The Security portion of the quote includes the perimetr fense intrusion detection and door switches for the plant. These alarm points would be wired back to the PLC and enabled through the SCADA system for remote dialout.

The Autodialer relocation involves moving the existing autodialer from the old location to the new location and includes PLC programming.

Checkout/Startup/Testing is included to facilitate and document a complete and working system.
