

Lane County Parks Natural Areas Operations Report for January 2022 - Ed Alverson

- -I contributed to budget discussions by providing budget numbers for various projects to include in the FY 22-23 budget.
- -I was interviewed by a Register-Guard reporter for an article that appeared on 1/31.
- -I participated in a site visit with Friends and BPA staff to examine erosion on Trail 6 at HBRA, which is maintained by BPA as a transmission line access road.
- -I facilitated conversations and analysis with HBRA stakeholders and representatives of the Staffordshire Homeowners Association about the status if their property adjacent to HBRA.
- -The union review process for the 2022 Friends of Buford Park 2022 HBRA work was completed.
- -I participated in HBRA stakeholder meetings
- Holiday Farm Fire: I participated in a FEMA meeting; additional conversations to explore options for completing hazard tree removal from Eagle Rock Park.
- Lane County Bicycle Master Plan: I participated in a meeting to refine strategies for a proposed regional bicycle trails plan that may be included as a project in the BMP.
- -I continued to coordinate with the contractor implementing the Hendricks Bridge Park boat ramp mitigation project, though weather issues put much of the activity on hold.
- -I coordinated with McKenzie Trust staff regarding various conservation land opportunities in the county.
- -I met with a park visitor and followed up with other Parks and Public Works staff regarding a newly established camp site in Hileman Park.
- -I contributed to an on-site meeting to discuss a draft layout of sites for the Armitage Campground expansion.
- -I reviewed a report on alignment options for the Coast Trail in the vicinity of Florence.
- -I participated on the interview panel for the Parks Volunteer and Marketing Coordinator position.
- -Research and education: I spoke to a UO environmental studies class studying tree measurement methods in the Spring Box savanna at HBRA. I toured the Meadowlark East area to discuss a proposed research project studying the fungi found in burned and unburned examples of prairie and savanna habitat. I arranged to lead two field trips to lane County parks this coming spring for the Native Plant Society of Oregon.
- -Partnership efforts: I participated in a Rivers to Ridges 2021 prescribed burning planning meeting; and a Friends of Buford Park trails Committee meeting.
