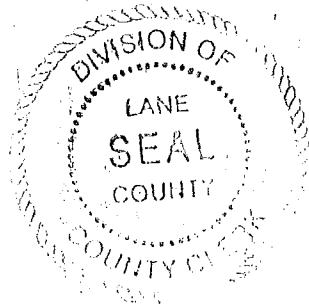

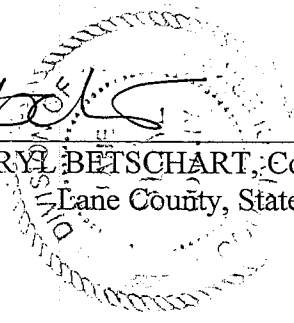

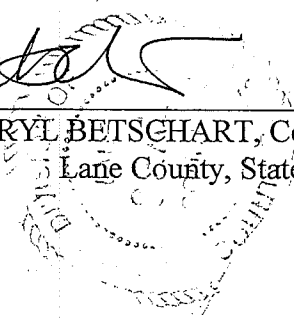
Greeting:
