ORDER NO: 16-05-03-07

IN THE MATTER OF ANNEXING TERRITORY TO THE MCKENZIE FIRE AND RESCUE DISTRICT TO PROVIDE FIRE PROTECTION SERVICE TO THE ANNEXATION TERRITORY, CONSISTING OF PORTIONS OF TRS 17-01-32-40 TAXLOTS 1006, 1011, & 1012, AND SETTING THE FINAL HEARING. (FILE NO. F-MK-2016-ANX-1)

**WHEREAS**, a petition initiating the annexation of territory to the McKenzie Fire and Rescue District was filed with Lane County on March 18, 2016 (the "Petition for Annexation"), in accordance with ORS 198.855(3); and

**WHEREAS**, the territory proposed for annexation is described in Exhibit A and depicted on the map shown on Exhibit B, both of which are attached and incorporated by this reference; and

**WHEREAS**, the Board of Directors of the McKenzie Fire and Rescue District adopted two resolutions approving the proposed annexation, one on March 18, 2008 (Resolution 07/08 - 4) and February 16, 2016 (2015/2016 Resolution #7); and

**WHEREAS**, legal notice was provided on April 13, 2016 and April 22, 2016, for a May 3, 2016, public hearing; and

**WHEREAS**, the Board of County Commissioners conducted a public hearing on May 3, 2016, to receive and consider both oral and written evidence.

**NOW, THEREFORE, IT IS ORDERED** as follows:

1. That the findings set forth in Exhibit C are hereby adopted and incorporated by this reference.
2. That based on the findings and evidence submitted, and the applicable law, the Petition for Annexation is hereby approved.
3. That a final hearing be held before the Board of County Commissioners of May 24, 2016, for the purpose of determining whether a sufficient number of requests for election have been filed in accordance with ORS 198.810(3) such that election on the annexation is required as provided by ORS 198.855.
4. That notice of the final hearing on May 24, 2016, be published according to law.
5. That if a sufficient number of requests for an election have not been filed in accordance with ORS 198.810(3) by the time of the final hearing on May 24, 2016, the Board of County Commissioners will issue its final order approving the annexation of the territory described on Exhibit A and depicted on Exhibit B to the McKenzie Fire and Rescue, effective as of May 24, 2016, in accordance with ORS 198.747(2).
