**THIS MATTER** now coming before the Board of County Commissioners of Lane County and said Board deeming it in the best interest of Lane County to dedicate to the public the real property which was conveyed to Lane County for the purpose of widening the right of way of Gibson Lane (County Road Number 235) for a bridge construction project, as shown on a survey filed in Lane County Surveyor's Office, numbered County Survey File 32666; and

**WHEREAS**, the adoption of a Capital Improvement Program approved by the Board of Commissioners in Order 93-4-28-23 authorized Lane County to initiate property acquisition for the bridge project on Gibson Lane; and

**WHEREAS**, the Department of Public Works acquired a certain deed for real property for Lane County from Eileen Andrews Whitmore, recorded on Reel 1922R, Recorder's Reception number 9411198, Lane County, Oregon Deed Records, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept said deed as County Road; and

**NOW, THEREFORE, IT IS HEREBY ORDERED** that the right of way, as described in said deed, is hereby accepted by the Board of County Commissioners of Lane County as a public road easement, and expressly accepted as County Road by this Order; and

**IT IS FURTHER ORDERED** that the above Order shall be entered in the records of the Board of County Commissioners' Journal of Administration and in the road records for County Road Numbers 235 in the regular numbered road files in the County Surveyor's Office.
