WHEREAS, the Lane County Public Safety Coordinating Council (PSCC) advises the Board of County Commissioners on matters regarding adult and juvenile offenders, criminal justice policy, use of local and state resources for adult and juvenile criminal justice, and planning to prevent criminal involvement; and

WHEREAS, the Director of the Lane County Department of Youth Services is a ex-officio member of the PSCC; and

WHEREAS, Mr. Roland Hoskins has been designated Director of the Department of Youth Services; and

WHEREAS, the Lane County Regional Managers have designated Kevin Watson, City Administrator of Junction City, to represent small cities on the PSCC; and

WHEREAS, the terms for lay citizens Mr. Paul Solomon and Mr. Steve Davis expire December 31, 2011; and

WHEREAS, the PSCC recommends the Board of Commissioners reappoint Mr. Solomon and Mr. Davis; and

WHEREAS, these appointments are in line with PSCC Bylaws adopted by the PSCC and the Board of Commissioners and incorporated into the Lane Manual;


