WHEREAS, District Attorneys have been maintaining comprehensive victim assistance programs for many years in support of providing services to victims of all crimes; and

WHEREAS, the Legislative Assembly appropriated funds for the period October 1, 2012 through September 30, 2014 to encourage District Attorneys to maintain comprehensive victim assistance programs pursuant to ORS 147.227; and


WHEREAS, the Legislative Assembly intends that its appropriation of funds will yield enlargements or other improvements in the quality of the victim assistance programs in every county in Oregon; and,

WHEREAS, the Board of Commissioners may appropriate dedicated grant funds as per ORS 294.326.(3);


NOW, THEREFORE, IT IS HEREBY ORDERED that Lane County approve the intergovernmental agreement with the State of Oregon for VOCA Non-Competitive Program Grant in an amount not to exceed \$262,124; and

I. MOTION

1. MOVE APPROVAL OF THE ORDER DELEGATING CONTRACT SIGNATURE AUTHORITY TO THE COUNTY ADMINISTRATOR FOR THE DISTRICT ATTORNEY'S OFFICE VOCA NON-COMPETITIVE PROGRAM GRANT (DEPARTMENT OF JUSTICE - CRIME VICTIMS DIVISION).

II. AGENDA ITEM SUMMARY

The legislative assembly appropriated funds for the period October 1, 2012 through September 30, 2014 for counties and cities where prosecuting attorneys maintain comprehensive victims' assistance programs. The Board is being asked to delegate authority to the County Administrator to sign the intergovernmental agreement to accept these funds in an amount not to exceed \$262,124. The funds will be used by the District Attorney's Office to provide services to victims of all crimes.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. Background/Analysis

This item meets the Abbreviated Consent Calendar criteria in that it requests the Board delegate contract signature authority to the County Administrator for the District Attorney's Office VOCA Non-Competitive Program Grant (Department of Justice - Crime Victim Services Division).

B. Recommendation

I recommend that the Board of County Commissioners order that the County Administrator is delegated authority to execute an intergovernmental agreement with the State of Oregon in an amount not to exceed \$262,124 for a period beginning October 1, 2012 and ending September 30, 2014 for the District Attorney's VOCA Non-Competitive Program Grant, subject to legal counsel review.
