ORDER NO: 12-5-16- 05

IN THE MATTER OF ANNEXING TERRITORY TO  
THE LANE COUNTY FIRE DISTRICT #1 TO  
PROVIDE FIRE PROTECTION SERVICE TO THE  
ANNEXATION TERRITORY, CONSISTING OF LOTS  
8, 9 AND 11 OF EASY ACRES SUBDIVISION. (FILE  
NO. F-LC1-2011-ANX-2)

**WHEREAS**, a petition initiating the annexation of territory to the Lane County Fire District #1 was filed with Lane County on November 4, 2011 (the "Petition for Annexation"), in accordance with ORS 198.855(3); and

**WHEREAS**, the territory proposed for annexation is described in Exhibit A and depicted on the map shown on Exhibit B, both of which are attached and incorporated by this reference; and

**WHEREAS**, the Board of Directors of the Lane County Fire District #1 adopted a resolution approving the proposed annexation on October 13, 2011 (Resolution No. 10-10-11); and

**WHEREAS**, legal notice was provided on April 10, 2012 for an April 25, 2012 public hearing according to ORS 198.800; and

**WHEREAS**, the Board of County Commissioners (the "Board") conducted a public hearing on April 25, 2012, according to ORS 198.800, where it received and considered both oral and written evidence; and

**WHEREAS**, the Board preliminarily approved the petition for annexation in Order No. 12-4-25- 16, adopted findings supporting that decision, and set May 16, 2012 as the final hearing date to consider whether a sufficient number of requests for election have been filed in accordance with ORS 198.810(3) such that election on the annexation is required as provided by ORS 198.855; and

**WHEREAS**, legal notice was provided on May 1, 2012 for a May 16, 2012 public hearing according to ORS 198.800; and

**WHEREAS**, the Board of County Commissioners conducted a final hearing on May 16, 2012, to consider the question of whether an election is necessary; and

**WHEREAS**, the Board is informed by staff and through the public hearing that the County has not received a sufficient number of requests for an election such that election on the annexation is required, and the Board being otherwise fully informed.

**NOW, THEREFORE, THE BOARD FINDS**, that a sufficient number of requests for an election have not been filed in accordance with ORS 198.810(3); and

**THE BOARD THEREFORE ORDERS** that the territory described on Exhibit A and depicted on Exhibit B is hereby annexed to the Lane County Fire District #1 and that this annexation is effective as of May 16, 2012, in accordance with ORS 198.747(2).
