THIS MATTER now coming before the Board of County Commissioners for Lane County, Oregon, and the Board, through adoption of a Capital Improvement Program for the Department of Public Works, determined that it was necessary to reconstruct two bridges on Maple Drive (County Road Number 607); and

WHEREAS, the acquisition of right of way and bridge construction were authorized by the Board of Commissioners through the adoption of the Capital Improvement Program for FY 92/93 through FY 96/97, by Order No. 92-4-28-10; and

WHEREAS, the Department of Public Works acquired all necessary right of way on and over which the project has been laid out; and the deeds were recorded for public record in 1993, however, they were never formally accepted into the County Road system by the Board of County Commissioners; and

WHEREAS, the Department of Public Works completed the final road design and reconstruction of the bridges in accordance with the plans and specifications prepared and administered by the Public Works Director; and

WHEREAS, the Department of Public Works has filed a road survey in 1994 numbered County Survey File 32167 with the County Surveyor for public record, in compliance with ORS 209.250 and 368.106; and

WHEREAS, it has been determined necessary to legally alter this portion of Maple Drive and accept the alignment, including acquisitions made as a part of this project, as County Road right of way; and

WHEREAS, no portions of the former right of way alignment of County Road Number 607 will be vacated by this action; and

WHEREAS, the Board of County Commissioners is satisfied that necessary road construction and improvements have been completed and will be of public utility and benefit; now therefore, it is hereby

ORDERED that the deeds, or portions thereof, which lie within the Maple Drive right of way specified herein, presented to the said Board of County Commissioners through purchase, donation, or agreement, as herein set forth below, on the dates set after the names of the Grantors, and before the recording information in the Lane County Deed Records, are hereby accepted as County Road right of way:

ORDERED, that this Order be filed with the County Clerk and entered into the records of the Lane County Board of Commissioners Journal of Administration and into the County Road Files administered by the Lane County Department of Public Works and the Lane County Surveyor; and that said Order be, and is hereby final and does operate to alter said portion of Maple Drive, and to accept it as County Road Number 607.
