WHEREAS, the improvements associated with this project have been completed in accordance with the plans and specifications prepared and administered by the Public Works Director; and

WHEREAS, it has been determined necessary to legally alter this segment of River Road and the intersection with Love Lake Road, and accept the alignment including acquisitions of property made as a part of this project as county road right of way; and

WHEREAS, the Department of Public Works has filed road survey numbered County Survey File 32457 with the County Surveyor for public record all in compliance with ORS 209.250 and 368.106; and

WHEREAS, the Board of County Commissioners is satisfied that necessary road construction and improvements have been completed and will be of public utility and benefit; now therefore, it is hereby

ORDERED, that the deeds and right of way grant specified herein, presented to the said Board of County Commissioners through purchase, donation, or agreement, as herein set forth below, on the dates set after the names of the Grantors, and before the recording information in the Lane County Deed Records, are hereby accepted as County Road right of way:
