-) River Rd. Milepost 4 Projects

WHEREAS, the Oregon Department of Transportation (ODOT) is requesting Notices of Intent to apply for Transportation Enhancement and Bicycle and Pedestrian (TE-OBPAC) Program grant monies; and

WHEREAS, Lane County adopted the 2013-2017 Road Fund Capital Improvement Program (CIP) on May 9, 2012, including an annual allocation for Safety Improvements; and

WHEREAS, the City of Springfield identified a need for a pedestrian-bicycle crossing traffic control system at the intersection of Bob Straub Parkway and Mt. Vernon Road; and

WHEREAS, the Bob Straub Parkway at Mt. Vernon Road project is called out in the adopted CIP and is eligible to pursue once funding opportunities such as the TE-OBPAC Program are identified; and


WHEREAS, the County has also identified the need for safety improvements at the Row River Trail-Row River Road milepost 4 intersection and has been partnering with the Bureau of Land Management to plan and design this project; and


WHEREAS, the implementation of the Row River Trail-Row River Road project is consistent with adopted Transportation System Plan policies; now, therefore, it is hereby

ORDERED, that Lane County Public Works be authorized to submit to ODOT Notices of Intent to apply for these two projects, substantially in conformance with the Notices of Intent in Exhibit A to this Order, and if invited to apply, the County Administrator be authorized to sign TE-OBPAC grant applications for the two projects, requesting approximately \$200,000.00 in grant funds for the Bob Straub Parkway project and approximately \$512,000 for the Row River Trail-Row River Road project, and committing Lane County to providing a 10.27% match for each of the respective projects, if funded; and,

ORDERED, that if the grant(s) are approved, the County Administrator be authorized to execute associated Intergovernmental Agreements to proceed with the project(s) and be reimbursed through the grant program.
