THIS MATTER now coming before the Board of County Commissioners of Lane County and the United States, acting by and through the Forest Service, Department of Agriculture, owning land within Lane County which is not within the limits of an incorporated city or town, having on this day presented to the Board of County Commissioners of Lane County a good and sufficient right of way easement, being properly executed and granting a portion of such land to the use of the public for road purposes, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept said grant for a public road easement; and

WHEREAS, the purpose of the easement is to provide additional width to the existing 40-foot wide right of way for an area of Big Creek Road and Upper North Fork Road that needs improvement due to an embankment failure; and

WHEREAS, said right of way easement has been recorded on Instrument Number 2012-017147 on April 12, 2012 in Lane County Deed Records, and depicted on County Survey File Number 42329, filed in the Lane County Surveyor's Office; and

THEREFORE, IT IS HEREBY ORDERED that the said right of way grant shall be and is hereby accepted by the Board of County Commissioners of Lane County as a public road easement; and

IT IS FURTHER ORDERED that the described right of way is expressly accepted as a County Road by this Order; and

IT IS FURTHER ORDERED that the above Order shall be entered in the records of the Board of County Commissioners' Journal of Administration and in the road records for County Road Number 669 in the regular numbered road files in the County Surveyor's Office.
