THIS MATTER now coming before the Board of County Commissioners of Lane County and said Board deeming it in the best interest of Lane County to dedicate to the public the real property which was conveyed to Lane County for the purpose of widening the right of way of Perkins Road (County Road Number 408) for two bridge construction projects, as shown on surveys filed in Lane County Surveyor's Office, numbered County Survey File 33308-33309; and

WHEREAS, the adoption of a Capital Improvement Program approved by the Board of Commissioners in Order 93-4-28-23 authorized Lane County to initiate property acquisition for the bridge projects on Perkins Road; and

WHEREAS, the Department of Public Works acquired certain deeds for real property for Lane County, properly executed on the dates set after the names of the Grantors, and before the recording information in the Lane County Deed Records, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept the following deeds as county road as herein set forth below:
