ORDER NO. 12-2-1-10 | THE MATTER OF APPOINTING REPRESENTATIVES AND LIAISONS TO VARIOUS COMMITTEES AND AGENCIES

WHEREAS, the Board of Commissioners annually assigns one of its members as a liaison to various committees, councils, districts or agencies during the month of January; and

WHEREAS, from time to time, the appointed Commissioner is unable to attend or otherwise wishes to have a delegate attend in lieu of the Commissioner; and

WHEREAS, the Board of Commissioners has considered these appointments.

NOW THEREFORE IT IS HEREBY ORDERED that the Lane County Board of Commissioners will be represented at the following committees/agencies by the identified Commissioner below, in a liaison capacity, and

IT IS FURTHER ORDERED that the indicated Commissioner may appoint a delegate to attend the agency or committee meetings on the Commissioner's behalf, which appointment shall be in writing and delivered to the appropriate staff for entry into the records of the committee or agency. The delegate shall be responsible for reporting back on the activities of the agency or committee to the appointing Commissioner.
