THIS MATTER now coming before the Board of County Commissioners of Lane County and said Board deeming it in the best interest of Lane County to dedicate to the public the real property which was conveyed to Lane County for the purpose of widening the right of way of Weiss Road (County Road Number 1171) for a bridge construction project, as shown on a survey filed in Lane County Surveyor's Office, numbered County Survey File 28774; and

WHEREAS, the project was part of the Capital Improvement Program approved by the Board of Commissioners in Order 81-5-13-23; and

WHEREAS, the Department of Public Works acquired a certain deed for real property for Lane County, properly executed on the date set after the name of the Grantor, and before the recording information in the Lane County Deed Records, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept the following deed as County Road as herein set forth below:

IT IS FURTHER ORDERED that the above Order shall be entered in the records of the Board of County Commissioners' Journal of Administration and in the road records for County Road Number 1171 in the regular numbered road files in the County Surveyor's Office.

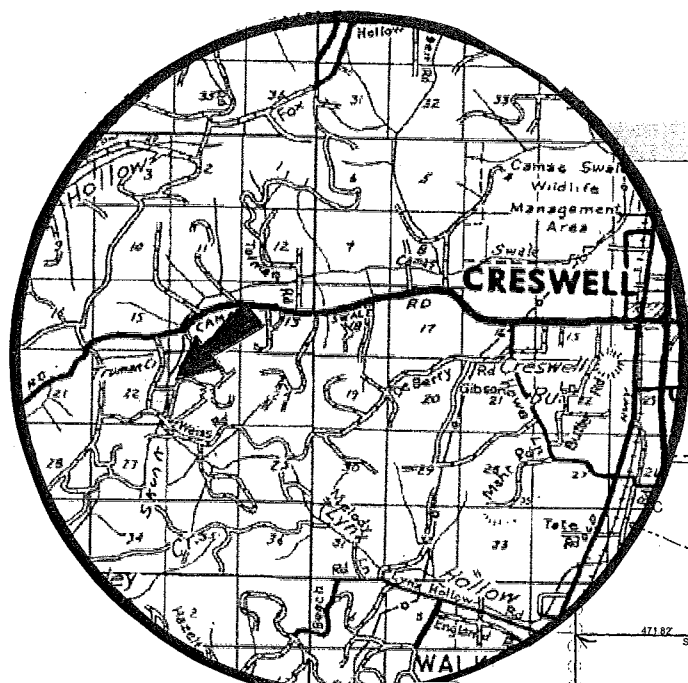
