ADDITIONAL TERMS AND CONDITIONS

DEPOSIT: At the conclusion of the bid opening, Lane County will notify you via phone **AND** email, if provided, if you are the successful bidder for this property. You will be required to deliver cash or a cashier's check (personal and business checks will NOT be accepted) in the amount of 20% of the bid offer. At that time, you will be issued a Sheriff's Certificate of Sale. If your deposit is not received by 2:00pm on the next business day following the bid opening, your bid will be forfeited and the property will be offered to the next highest bidder.

BALANCE: The balance of the purchase price plus \$100 recording fee is due no later than 4:00 pm on the 5th business day following the bid opening. Only cash or certified funds will be accepted. Upon acceptance of the successful bids from the Lane County Board of Commissioners, a Quitclaim Deed will be executed, recorded and delivered to the buyer. If bidder fails to pay the full purchase price within the time and in the manner set forth above, bidder's rights, title and interest in the property shall cease and ownership shall remain vested in Lane County. Any monies deposited by bidder shall be retained by Lane County.

Properties are sold on an "as is, where is" basis. The sale of this property is subject to any existing easements, restrictions, reservations or special assessments. Conveyance will be made by Quitclaim Deed. No warranty or guarantee, expressed or implied, is made regarding condition of title (encumbrances, liens, easements, etc.), ability to use a property for any particular purpose pursuant to Oregon land use law, existence of legal access, location of property boundaries or any other matter concerning a property. Lane County does not offer title insurance or a title report on tax foreclosed properties. It is recommended that before making an offer, the bidder fully investigates the property.
