NATURE OF STORY: Third Suspect Arrested in Connection with Home Invasion Robbery off Northhill Ranch Rd. in Eugene

Robbery in the Second Degree x 6
Assault in the Second Degree x 2
Burglary in the First Degree

DETAILS:

On 7/19/2018, Daniel Hoeve-Chavez (18 years old, Springfield) was located by the Eugene Police Department and arrested on multiple charges in connection with the robbery that occurred off Northhill Ranch Road on June 13, 2018. Hoeve-Chavez was the third and last suspect to be taken into custody in this case, and is being held at the Lane County Jail.



The other two suspects in this case, 18 year old Daniel Cole Carter and 21 year old Dylan Haines, remain in custody at the Lane County Jail.

Previous News Release 6/28/2018

The Lane County Sheriff's Office has identified and arrested a second suspect in connection with the robbery that occurred off Northhill Ranch Road on June 13, 2018. Sheriff's Office detectives contacted 18 year old Daniel Cole Carter yesterday afternoon and arrested him on three counts of Robbery in the first degree, two counts of Assault in the second degree, and one count of Unlawful Use of a Weapon. Carter was lodged in the Lane County Jail and is scheduled to be arraigned today.

21 year old Dylan Haines was arrested in June 15th in connection with the robbery and at that time, the identity of Carter was unknown.

The Sheriff's Office is still searching for the third suspect in this case, identified as 18 year old Daniel Hoeve-Chavez of Eugene. Previous News Release 6/21/2018

The Lane County Sheriff's Office is seeking the public's assistance locating a suspect in a home invasion robbery incident that occurred at the 86000 block of Northhill Ranch Road in Eugene on 6/13/2018 shortly after 4:00 am.

Investigation indicates that three suspects entered an RV on the property and assaulted a 20 year old male and a 44 year old male. The suspects demanded money, and fled with an undisclosed amount of marijuana. A 33 year old female was also present in the RV but uninjured.

The Lane County Sheriff's Office arrested 21 year old Dylan Haines of Eugene on June 15th in connection with the robbery. A second suspect has been identified as 18 year old Daniel Hoeve-Chavez (pictured) of Eugene. The third suspect in the robbery has not yet been identified.

The Lane County Sheriff's Office is seeking the public's assistance in locating Hoeve -Chavez. Anyone who has information on Hoeve-Chavez's location is asked to contact the Lane County Sheriff's Office at 541-682-4141. Community members are urged not to approach or attempt to apprehend Hoeve-Chavez.
